<h3 style="margin: 0;">Ohio BoSCoC HIC/PIT Requirements</h3> <ul style="list-style-type: none"> HUD requires an annual count of sheltered and unsheltered homeless persons for communities receiving federal funding from the CoC and ESG Programs. These are called Point-in-Time Counts (PIT), as they occur during one day, the last ten days of January. This year, the Ohio Balance of State Continuum of Care (BoSCoC) will hold its PIT Count on January 23, 2018.

<h3 style="margin: 0;">2018 HIC/PIT Reminders</h3> <ul style="list-style-type: none"> All Ohio BoSCoC counties must complete a sheltered and unsheltered PIT Count <ul style="list-style-type: none"> Unsheltered PIT Count must include a street count (the night of 1/23) AND a service-based count (the days immediately after) Sheltered Count is pulled from HMIS for HMIS-participating providers, and non HMIS-participating providers complete survey tools with clients on the night of the PIT Count

<h3 style="margin: 0;">2018 HIC/PIT Reminders</h3> <ul style="list-style-type: none"> Only some projects must submit Housing Inventory Count (HIC) information this year, including: <ul style="list-style-type: none"> Projects with any changes to report Projects with bed and/or unit utilization concerns All non-HMIS participating projects Projects that participate in HMIS, have experienced no changes to capacity or design, and have no issues with utilization, will not need to submit any HIC info

<h3>CE Post Launch: Next Steps</h3> <ul style="list-style-type: none"> • Regional Provider Surveys: expect to receive two to three months post your region’s launch date • CE Collaborative and CE Staff will start to finalize the monitoring and evaluation process for CE • TAY-VI-SPDAT <ul style="list-style-type: none"> • Regions 2, 16, and 17: only regions cleared to assess with TAY • By Early May 2018: host two webinars providing additional guidance on serving youth • Post Training: remaining regions will implement TAY assessments

<h3>CE Collaborative</h3> <ul style="list-style-type: none"> • Will consists of CE liaisons: one from each region • Each region selected their CE liaison November 2017 • Next Steps: beginning late December-early January <ul style="list-style-type: none"> • Initial meeting with all CE liaisons: introduce to role • Begin regular CE Collaborative meeting attendance • Train CE liaisons in diversion training

- Written RRH Standards
- BoSCoC Staff and the Training and Technical Assistance Coordinator are finalizing the RRH standards.
- Introductory webinar Part 1: Development of Standards
 - RRH is a short-term intervention to help individuals and families exit homelessness as quickly as possible, move into permanent housing, and achieve stability in housing

 - Housing Identification Assistance

- Develop sample or template tools as needed

Background

- \$33 million from HUD available to help communities develop and implement an innovative coordinated community plan to ending youth homelessness
- \$2.2 million was awarded to advance this work in Athens, Vinton, Meigs, Jackson, and Gallia counties
- A variety of local and state stakeholders are participating in the planning process, including homeless service providers, schools, child welfare agencies, youth advisory boards, the Ohio Department of Education and other community partners
