The Trump administration's budget proposal came out earlier this month and its bad news for housing and homeless advocates. The president <u>wants to cut HUD's budget</u> by \$8.8 billion, or 18.3 percent.

The good news is, this is just a proposal that still has to get through the House and Senate. And it comes just weeks after Congress approved a bipartisan deal to lift austere spending caps that have starved HUD programs for years. With \$131 billion in new domestic spending authority, this is the first opportunity to increase federal funding for housing and homeless services in a very long time.

That's why we drafted this sign-on letter asking Ohio's Congressional Delegation to support increased funding for rental assistance, homeless grants, public housing, Community Development Block Grants, HOME and the National Housing Trust Fund. We're asking nonprofits, businesses, and organizations throughout the state to add their names to the Ohio Homes, Ohio Voices sign-on letter.

Then we'll work with local agencies and advocates to hand-deliver the letter to their Congressional members' district offices during the <u>National Housing Week of Action</u> in May 1-8. That's when advocates stage events throughout the nation to draw attention to the importance of safe, decent, affordable housing.

In addition to making the case for a healthier HUD budget, we have to tell legislators why the administration's plans to increase rents and impose work

requirements on people with housing assistance are counterproductive. Raising the rent on people who are already struggling to make ends meet will make it harder for them to keep a job and stay healthy because they'll will have less money to pay for things like transportation, medicine and childcare.

The president's budget revives out-of-date, inaccurate stereotypes of poor people. The fact is, nearly 90 percent of households with rental assistance are elderly, disabled, or already working. The problem is not that people with housing assistance don't work. It's that working people can't afford housing without assistance in this low-wage, part-time economy.

# President Trump's HUD Budget Would Increase Housing Insecurity

President Trump's Fiscal Year 2019 budget would cut HUD by \$8.8 billion, or 18.3 percent, according to <u>an analysis</u> by NLIHC. Under this proposal, Ohio would lose an estimated 8,411 Housing Choice vouchers which keep low-income working families, seniors, and people with disabilities stably housed. The budget would also raise rents and impose work requirements on people with rental assistance.

"Dr. Carson often talks about how decent, affordable housing is essential for people's health and well-being. Unfortunately, his boss's new budget is bad medicine at a time when more and more

Ohioans are struggling to pay the rent," said Bill Faith, executive director of COHHIO. "Cutting HUD will increase housing insecurity and homelessness, which has negative health consequences and other bad outcomes for Ohio."

## Slay the Gerrymander!

The 2018 elections promise to shakeup the state and national political scenes, starting with a ballot issue in May that could go a long way toward fixing Ohio's system of gerrymandered Congressional districts.

COHHIO has supported the <u>Fair Districts = Fair Elections</u> coalition's effort to reform the way state legislators redraw Congressional district maps to maximize their partisan advantage. ### **State Releases \$26 Million in Homeless Grants**

The Ohio Development Services Agency recently awarded grants totaling nearly \$26 million in state and federal funding to help 72 local agencies working to prevent homelessness, provide emergency shelter, and operate permanent housing initiatives.

The announcement generated some positive local media coverage, like a more than \$1 million <a href="Homeless Crisis Response Program">Homeless Crisis Response Program</a> grant to WSOS Community Action Commission to help provide homeless prevention and rapid re-housing services across a seven county region in Northwest Ohio. The Caring Kitchen Inc., which provides emergency shelter, a food pantry, tutoring, clothing and other services in Champaign County, also got <a href="mailto:brief coverage">brief coverage</a> in the Springfield News-Sun about their \$109,500 grant. <a href="Click here for more information">Click here for more information</a>.

### **BoSCoC Launches Providers Peer Discussion Group**

Over the past few years, Ohio Balance of State Continuum of Care staff have rolled out a number of new standards, requirements, and processes including Homeless Program standards, Coordinated Entry standards and processes, and detailed Point-in-Time Count and Housing Inventory County requirements, among others.

In an effort to provide more tools to help providers understand all these requirements and how to implement them, the BoSCoC team has created a new email-based peer discussion group to enable providers to communicate with one another about whatever topics they choose. # Southeast Ohio Youth Homeless Project Seeks Partners

In early 2017, a team of service providers and system leaders representing a five-county region in Southeast Ohio (SEOH) were awarded funding as part of the Youth Homelessness Demonstration Program (YHDP), a federal initiative to develop community responses to prevent and end youth homelessness. The SEOH YHDP region includes Athens, Gallia, Jackson, Meigs and Vinton counties.

As a part of this initiative a work group was formed with members from COHHIO, Sojourners, Integrated Services, and other individuals and organizations from the SEOH region to write a Coordinated Community Plan (CCP) to guide the implementation of new projects with the overall goal of ending youth homelessness in the five county YHDP area.
