• Defining Youth Homelessness

- **U.S. Department of Housing and Urban Development (HUD):** Defines homelessness for their programs into four categories:
 - Category 1: Literally Homeless
 - Category 2: Imminent Risk of Homelessness
 - Category 3: Homeless under other Federal statutes
 - Category 4: Fleeing/Attempting to Flee Domestic Violence
- **U.S. Department of Health and Human Services (HHS) :** The Runaway and Homeless Youth Act (RHYA) RHYA (42 U.S.C. §5732a)
- **U.S. Department of Education** Subtitle VII-B of the McKinney-Vento Homeless Assistance Act

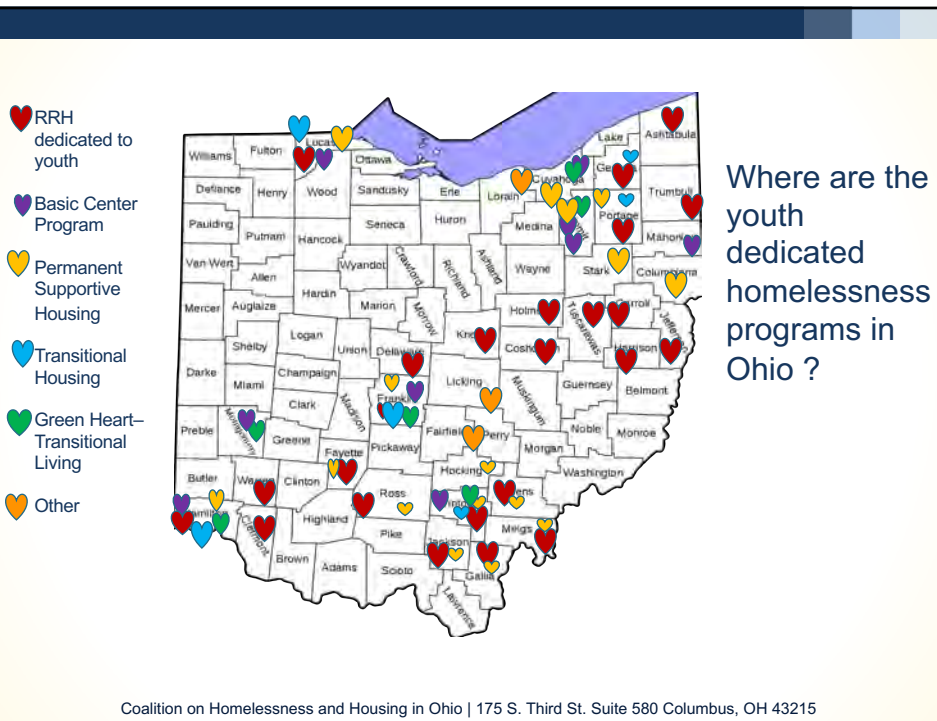
Youth homelessness is a national crisis

- Does that seem like a dramatic statement?...It's not.
- About 7% of the total homeless population is comprised of unaccompanied youth under the age of 25, according to the [National Alliance to End Homelessness](#).
- Even more shockingly, a recent national study by [Voices of Youth Count](#) at the University of Chicago's [Chapin Hall](#) found that about 10% of all youth age 18–25 experienced some form of homelessness over a 12-month period.

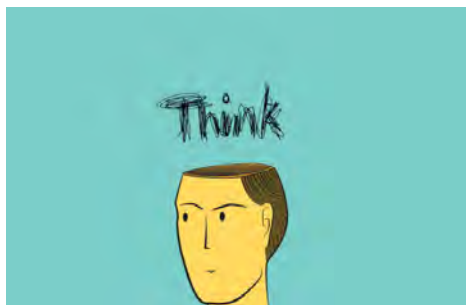

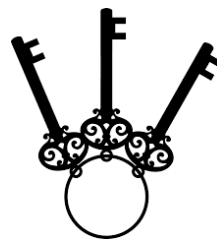

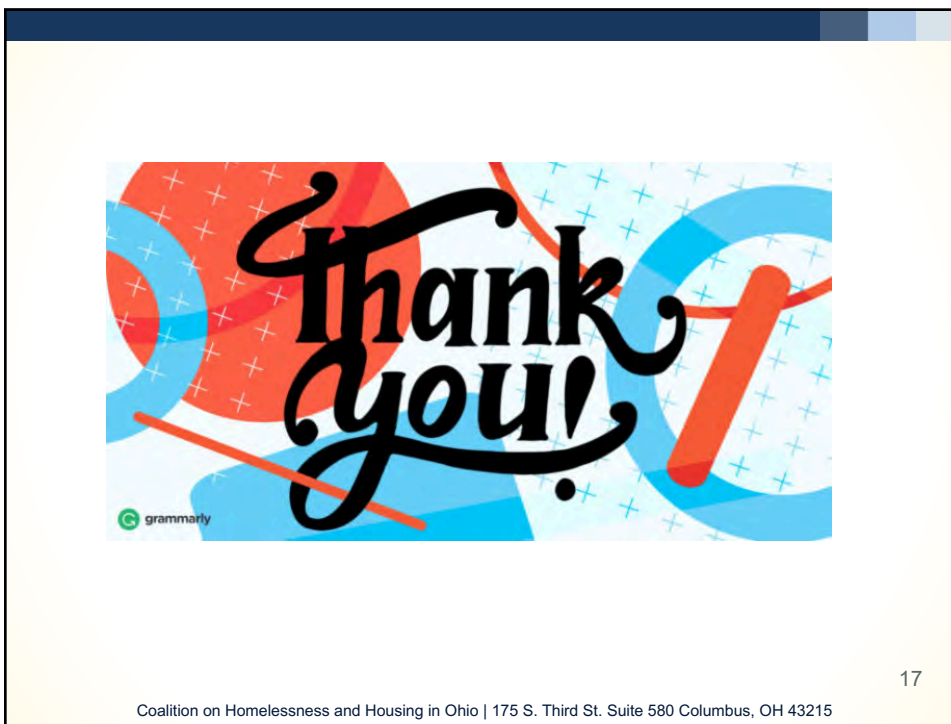
