## Introduction

- CDC issued a federal eviction moratorium in effect from September 4, 2020 – January 31, 2021
- “Eviction” means any action by a landlord to remove or cause the removal of covered persons from a residential property

## Introduction

- Postpones evictions for *non-payment of rent*, but does not prevent them
- As of now, on January 31, 2021, the moratorium will end and current and back rent will be due
  - Late fees and other charges may also be due in addition to rent

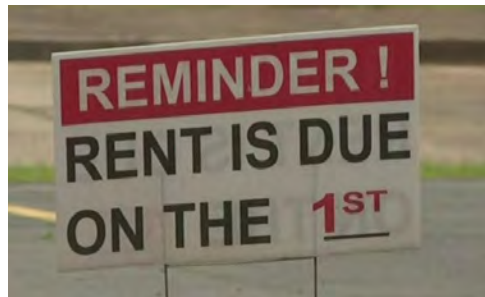

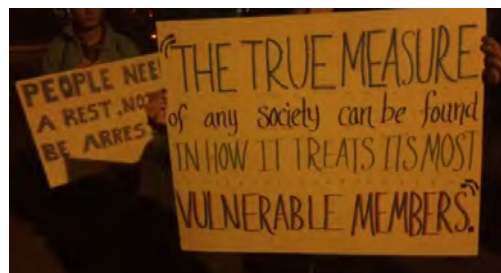
