Introduction

- On December 14, 2020 the state of Ohio began administering the first COVID-19 vaccinations to health care workers
- People residing in emergency shelters, and people experiencing homelessness have been included in Phase 2 of Ohio's vaccine distribution plan
 - Phase 2 of Ohio's vaccination plan also includes people with comorbid and underlying conditions, which may include people experiencing homelessness and residing in places other than emergency shelters





Introduction

- Tracking Vaccines:
 - COVID-19 vaccines must be administered in multiple doses, with 3-4 weeks in between doses
 - Tracking who has received the first dose and needs a second dose will be key, but also challenging
 - Speak with CoC about how to potentially use HMIS to track vaccine doses and distribution
 - Reach out to COHHIO for any questions regarding tracking


