

SOARing Together Series 2: Letter 10 2021 Work Incentives

There are many myths around the idea that individuals with disabling conditions receiving Social Security Disability benefits (SSI/SSDI) or those starting the disability application process should not seek employment for fear of losing their current disability benefits or having the application denied. The real facts are that the Social Security Administration has made special rules to allow people receiving and applying for SSI/SSDI to work and still receive benefits.

As SOAR Specialists, the SSA Blue Book Listings is pretty familiar for identifying a covered disability. https://www.ssa.gov/disability/professionals/bluebook/AdultListings.htm.\_ Social Security also has the SSA Red Book for identifying services offered directly through Social Security for employment while or applying for disability benefits

The SS Red Book contains a general description of the disability-related support programs. It will give guidance for SS benefits recipients who want to start or return to work without losing disability benefits. These programs, referred to as work incentives can be used for both the Supplemental Security Income (SSI) and the Social Security Disability Income (SSDI) programs. Each of these work incentive programs are unique and individualized supports. A wide range of programs are available, including incentives for individuals wanting:

- To go to college: Student Earned Income Exclusion (SEIE) -https://www.ssa.gov/oact/cola/studentEIE.html
- Support while working with an impairment: Impairment-Related Work Expenses (IRWE) -https://choosework.ssa.gov/library/2018-11-28-faq-impairment-related-work-expenses
- To test their ability to work: Trial Work Period (TWP) -https://www.ssa.gov/oact/cola/twp.html
- To prepare for or maintain success with employment: Ticket to Work -https://choosework.ssa.gov/about/how-it-works/index.html

Encouraging employment can assist applicants by building self-worth and confidence, establish an active role in their communities, add meaning and structure to their daily life, and reach employment or career goals.
