## Governance Charter Updates

### *Member Compensation & Working with Persons with Lived Expertise*

- CoC Board, Committee, and Workgroup members who represent a priority population may be compensated for their time spent participating in CoC meetings
- Compensation is provided via a stipend paid to the eligible member on a quarterly basis.
- The stipend amount is calculated based on estimated number of hours expected for meeting attendance and work outside of meetings, multiplied by \$50 per hour

### *Ohio BoSCoC Youth Action Board*

- Consists of youth members from across the CoC that are interested in sharing their voice for the purpose of the YHDP application and planning process
- At a future time, the CoC will seek to expand the YAB's focus to include serving as an advisory group on all matters relating to ending youth homelessness in the CoC
- Open to youth ages 14-24 with lived experience of homelessness or interest in ending youth homelessness

- ESG-CV expenditure deadline has been extended to September 2023



## 2022 Point-in-Time Count

- HIC Data:

- 3334 ES beds reported (59% increase from 2021)
- 857 TH beds reported
- 1237 RRH beds reported (34% decrease from 2021)
- 3575 PSH beds reported (8% decrease from 2021)

- PIT Data:


- 2769 total people in shelter (18% increase from 2021 & highest number reported since 2015)
- 1306 total people unsheltered (32% increase from 2020 & highest unsheltered number since 2009)
- 4075 total persons experiencing homelessness (highest number reported since 2012)

## 2022 Point-in-Time Count

### Takeaways from HIC/PIT Data:

- Increase in ES shows that congregate shelters are likely back to full capacity
- Pandemic funds are still being used for non-congregate shelter
- Significant decrease in RRH utilization on the PIT night despite increase in ES utilization
  - Lack of affordable housing units likely contributing to these numbers
- Again, in 2022, we saw the highest number of people in shelter, unsheltered, and the highest total number of people experiencing homelessness in several years
