1) Welcome- Douglas – Douglas opened the meeting at 4:05pm.

2) Framing and Flow – Douglas

- a) Confirm/modify agenda-No modifications or updates requested by attendees.
- b) Confirm quorum Not confirmed, however no voting items on the agenda.

3) Cross-site lead updates – Shayna

- a) COHHIO
 - Coordinator report

Shayna highlighted items from the PC report: Updated on the current training schedule. Overview of HBAH has been added to the schedule, if anyone needs this training, reach out off line. Also outlined the results of the fidelity review survey, which was over all satisfactory.

 Advocacy Updates and next steps
Shayna highlighted that the Governor's office has committed to \$17 million for HBAH. A gap funding proposal was submitted to the Governor's office, from COHHIO, no response received to date.

4) Research updates – Amy

a) Monthly enrollment/ Birth outcomes

Amy provided the location of the monthly reports: Drop box>HPIO>data reporting>monthly reports. Will continue to share monthly to each individual site.

b) Transition

Amy shared that she will be leaving HPIO in the summer. HPIO is also transitioning out of the research. HBAH presents some challenges as HPIO is composed of a small staff and HBAH is a large and complex study. HPIO is working with COHHIO on a transition plan. Amy affirms that there will be little impact on the participants or staff.

Douglas added: COHHIO has been in conversations with a major University in Ohio, to possibly take over the research. Douglas and Amy Riegel will be in discussions over the next 2-3 weeks. COHHO will keep everyone up to date.

5) Site updates

a) Akron-Bridget

Akron has an intake interview this day for a potential new participant, hopefully the applicant will be active 2/24/23. New HSS started Tuesday and has been in contact with Shayna for training. She is up and running with her training plan.

b) Columbus – LaShone/Rachael/Melissa

HFF remains on an intake pause, they will firm up what lifting the pause will look like. HFF will have to meet with StepOne to create a plan. HFF has been forwarding RTA packets and having them pushed through, which contributed to the pause. Looking to open back up intakes/enrollment next month (March). Interim Clinical supervisor is on board and working with staff. Compliance team working on scanning documents in so that they will be electronic when enrollment resumes. Working on invoicing and getting things in alignment with fidelity.
