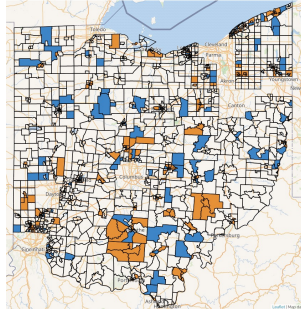

2023 Point-in-Time Count

- PIT count was held on the night of January 24th, 2023
- Sampling and Extrapolation used
 - Fewer census tracts were sampled in 2023 than in 2022
 - Will strive to include more census tracts/Known Locations in 2024
- Service-based count was utilized by many communities
- Preliminary PIT Data:
 - **2613** total people in shelter
 - **1232** total people unsheltered
 - **3845** total persons experiencing homelessness (second highest number reported in last 10 years)

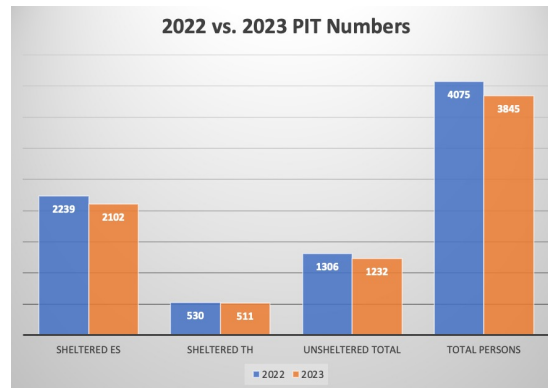

2023 Point-in-Time Count

Takeaways from HIC/PIT Data:

- 2023 count vs. 2022 count differences:
 - 137 less people in ES
 - 19 less in TH
 - 74 less counted in unsheltered count

2023 Point-in-Time Count

Takeaways from HIC/PIT Data:

- 2022 PIT was delayed until 2/22/22
 - The average evening temp was ~50 degrees in Feb of 2022
 - The average evening temp was ~30 degrees in Jan of 2023
- More COVID funding was used for emergency shelter last year
- Sampling approach used included census tracts with Known Locations of a minimum of 3 people
 - In 2022, there was a minimum of 1 person

CE Evaluation

- Annual evaluation of CE implementation required
- Working with C4 Innovations to complete evaluation over next six months
- Evaluation involves
 - Review of HMIS Data
 - Surveys to sample of providers
 - Intensive focus on 2 Homeless Planning Regions, to deepen understanding of CE implementation
 - Listening sessions, interviews
 - Interviews with people who have experienced homelessness and navigated CE system
- CE Evaluation Kick-Off Meeting
 - March 28, 2023 at 11am

CE Document Updates

- CE Operational Manual
 - Added a Guiding Principle focus on using our CE system to advance race equity
 - Added a Standard and clarifying language to Component #1 standards (Access), including establishing requirement that Regions must designate an agency to be responsible for maintain and distributing CE AP advertising materials
 - Streamlined standards in Component #5 related to entry into shelters via CE
 - Added standard re: how the CoC annually collects feedback from providers and households navigating CE and incorporates into CE System Standards
 - Added guidance re: how to document PH Prioritization decisions when non-chronically homeless are prioritized for PSH
