#### Agenda:

#### 1) Welcome- Douglas

- Asked for individual introductions of attendees.

### 2) Framing and Flow – Barb

- a) Confirm/modify agenda- Barb outlined today's agenda. No changes/updates requested by the collective.
- b) Confirm quorum- Confirmed.

## 3) Cross-site lead updates – Shayna

- a) COHHIO
  - Coordinator report

Shayna shared the procedural updates due to babies being born in Phase A as a result of housing delays.

- 2023 Meetings- Need to revise invite, last Thursday monthly versus 4<sup>th</sup> Thursday. A new link will be sent from COHHIO/HBAH zoom.
- Advocacy Updates and next steps- See PC report

Douglas provided update based on more recent developments: There was confirmation that HBAH will receive funding in the governor's budget, so it will not be available until July 1, 2023, at the earliest. It is positive that it is coming, however is later than we had initially hoped. The delay in funding, will cause a delay in research, therefore, we are asking for a funding gap to be filled by the Governor's office so that the other two sites can begin sooner than July.

## b) Barb Poppe Updates:

Fidelity Review Q1 Check-up: Barb informed that we committed to the State, that we will do quarterly reviews, CLC approved the new process, including checkup meetings, in December 2022. Each review will focus on different parts of the model. This checkup/ fidelity review, was focused on the quality of services provided, next checkup will be focused on housing. HPIO focuses on privacy and quality to standards. Duties were split between BPA and COHHIO, Barb shared whether fidelity was aligned and COHHIO provided technical assistance leading up to and afterwards. The process began at the end of December and the next steps is that Shayna will issue a survey for Fidelity participants. Feedback will be issued and any changes will be presented to the CLC. We also found that certain forms were not working as intended and those forms were corrected. It was definitely an opportunity for quality improvement. We are off schedule for having individuals housed within 30 days, in addition to staff turnover.

Akron was encouraged to move forward and work closely with Shayna as they move forward.

Columbus was encouraged to pause enrollment until qualitative improvements could be put in place for services moving forward.

The next round of Fidelity quarterly review will be in April. We want to make sure that as we celebrate funding, we move forward with quality procedures that meet our

intended research standards. We are confident that we will get to alignment to the model.

## 4) Research updates – Amy

a) Quarterly cross-site data report: We now have project data. The data is cumulative as of 1/18/23. 32 families that are actively enrolled, 1 has been disenrolled due to death.

The median weeks at enrollment was 18.5 weeks pregnant.

Medicaid enrollment: 50% are CareSource, 22% are United, 16% Molina and 9% are Buckeye

50% have no children, most (78%) are single adults

78% report no household income

61% have transportation barriers, 77% have food insecurity or are at risk, 29% have experienced family violence in the past 12 months

Director Stapleton asked about participants having "no household income," Amy shared that WIC and SNAP are not considered income but research does include SSI or TANF funds.

b) Medicaid analysis update: We are talking with OSU, Nationwide Children's, and GRC, on constructing a profiled group to compare with HBAH participants who have data as closely aligned as possible. Medicaid data will help make conclusions about the impact as well as healthcare utilization. Work is on-going.

# 5) Discussion and action needed

a. Incorporating changes to address situations where babies are born during Phase A-Action needed.

- Barb brought up a voting item, HBAH is not rehousing within 30 days and the consequence is that participants are delivering babies within Phase A before entering secure housing. We have two recommendations. One, we are considering moving down the gestational age of eligible participants to 23 weeks or less. This will help create a larger buffer for potential applicants who were eligible at screening but not on the Eligibility Day. We want to make sure that if any babies are born in Phase A that we have shifted to complete appropriate linkage questions and that the appropriate maternal health services as provided as appropriate, rather than waiting until Phase B. The vote is a change in the model and the screening process. This passed by a majority vote.

## c) Site updates

a. Akron Tanya:

Akron made an offer to an HSS applicant, and there has been a verbal acceptance for HBAH HSS. Bridget shared that the candidate can start on

February 20<sup>th</sup>. Akron is working on training plan and recalculating how long to enroll. Ramping up outreach.

#### b. Columbus – Rachael

Out of 29 participants are enrolled and 8 are stably housed. Columbus is paused until they can house more enrolled participants. Rachael also shared that the Columbus Team will continue to fine tune qualitative issues brought up during the quarterly fidelity review.

#### c. Cincinnati – Lauren

Great and detailed meeting with local partners to make sure they have the right people at the table, and that there is interest there. CradleOne continues to figure out how all of the potential partners will work together, and what is expected of each organization. Will be circling back in the next couple weeks.

#### d. Dayton – Lisa

GDAHA has posted, and interviewing strong candidates for Director of HBAH of Dayton. Hope to have on board and in training soon. The have experienced social workers who have worked with the homeless population.

- Rachael asked if we are still looking for external funding sources, managed care organizations, and we are continuing to reach out, we keep reaching out to others who want to give us. Every site should be brining 25% local match or local government funds. Lauren may have their local housing authority.
