Hello Ohio Balance of State and Mahoning County HMIS Users,

It came to our attention this morning that the HMIS vendor did not properly update program status and program exit screens with total monthly income calculations. This means that if you enter incomes for your clients who are having status updates or exits, the total monthly income field will not be calculated correctly. This issue will not impact your data entry. Please continue to enter income data as you normally would. We will email the listservs when the vendor resolves the issue.

2024 HUD Data Standards Changes

The HUD 2024 Data Standard changes are effective as of Sunday, October 1st, 2023.

Make sure you are collecting data in compliance with the new standards. If you think that something is missing in Clarity that affects your ability to enter the new data elements, or create/complete referrals, please notify the helpdesk at hmis@cohhio.org.

Effective October 1st, HMIS End Users should review choices with currently enrolled clients at the next appropriate encounter. Verify accuracy and update if incorrect. This includes fields such as Race and Ethnicity, Gender, Sexual Orientation (PSH), Military Branch, and Percent of AMI.
