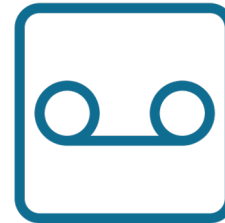

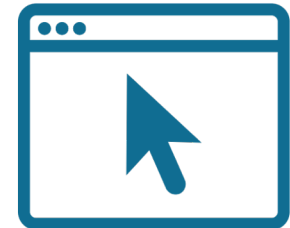

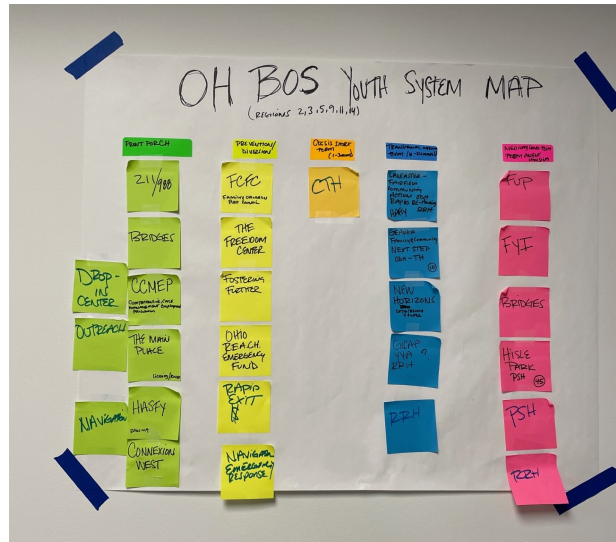
2024 Point-in-Time Count

FY2023 CoC Comp

- FY2023 CoC Competition Awards were announced on January 29, 2024
- The Ohio BoSCoC was awarded \$28,246,846
 - Includes 5 new projects funded

- Preparing for FY23 Grant Execution and the FY24 Competition

 - Ensure all APRs submitted and rejected APRs re-submitted (and accepted)
 - Ensure any outstanding Closeout Agreements are executed
 - Ensure your org's SAM.gov registration is active
 - Ensure your org's contacts in e-snaps are updated and correct

HCRP and SHP Applications

- Homeless Crisis Response Program (HCRP)
 - Provides funding for emergency shelter (ES), homelessness prevention (HP), and rapid re-housing (RRH) programs
 - HCRP-HP and RRH are allocated via formula to regional HCRP Leads
- Supportive Housing Program (SHP)
 - Provides funding for transitional housing (limited) and Permanent Supportive Housing (PSH) programs

HCRP and SHP Applications

- Homeless Crisis Response Program (HCRP) and Supportive Housing Program (SHP) Key Dates
 - HCRP Pre-App released 3/18/24
 - HCRP Pre-App closes 4/18/24
 - HCRP Application opens 5/20/24
 - HCRP Application closes 7/1/24
 - SHP Pre-App released 7/8/24
 - SHP Pre-App closes 8/8/24
 - SHP Application opens 9/9/24
 - SHP Application closes 10/21/24

- Draft version of Annual Action Plan is live
- Public Hearing for Annual Action Plan 3/12/2024
- Comment period
- Final determination of application processes

Ohio BoSCoC Process for Support

- All renewing and new applicants for HCRP and SHP funding must request Ohio BoSCoC support as part of their application submission
 - Applicants must submit the following to request CoC support
 - *Evidence of Continuum Support* document (with required parts completed)
 - NEW or EXPANSION FUNDING REQUESTS - Completed HCRP or SHP Pre-App
 - RENEWING REQUESTS – Project narrative and budget from 2024 application
