# Ohio Balance of State Continuum of Care 2024 Renewal CoC Project Preliminary Ranking Released

## **Purpose of this Listserv Message**

This message announces the release of preliminary 2024 CoC project ranking for Ohio BoSCoC renewing CoC Program projects.

### **Background Information**

Every year, the Ohio BoSCoC evaluates the performance of renewing CoC projects and uses those results to inform ranking of CoC projects within HUD's CoC Competition Project Priority Listing.

## **Voluntary Reallocation Policy and Improvement Action Plans**

Renewing CoC projects that did not receive at least 70% of the total available project evaluation points are at risk of having their funding involuntarily reallocated. <u>To retain renewal funding, low-scoring renewal recipients must submit an Improvement Action Plan (IAP) to ohioboscoc@cohhio.org by July 15, 2024</u>. If the CoC Board considers the IAP to be satisfactory, the recipient will be permitted to submit a renewal project application. Decisions about IAPs and potential funding reallocation will be made after HUD opens the FY2024 CoC Competition.

#### Appealing Project Evaluation Results or Ranking

Renewal CoC project recipients may submit appeals of project evaluation results or ranking. <u>Appeals must be emailed to the CoC at ohioboscoc@cohhio.org</u> by <u>Friday, June 28, 2024.</u> Those projects that are required to submit an IAP, and would also like to appeal project evaluation results, should ensure they submit an appeal by the June 28<sup>th</sup> deadline AND submit the required IAP by July 15<sup>th</sup>.

Late appeals will not be considered. Submitted appeals must indicate what is being appealed and must clearly demonstrate and explain how the results or ranking were the result of an error in fact or an undue hardship. The Ohio BoSCoC Steering Committee will review appeals and communicate decisions regarding those appeals by July 8, 2024. Steering Committee decisions are final.

### Project Evaluation Results, Ranking, and Funding Recommendations

HUD has not yet released information about funding availability for the FY2024 CoC Competition. Therefore, the Ohio BoSCoC Steering Committee has not yet made final funding recommendations for renewal or new CoC projects. Once funding availability information is released, the Ohio BoSCoC Steering Committee, with approval from the CoC Board, will identify a recommendation for funding renewal and new projects.
